## Re: HB 1273, waiving the admission fee to state parks for military dependents.

Dear Chair Smith and members of the committee,

Thank you for the opportunity to provide testimony on House Bill 1273, waiving the admission fee to state parks for military dependents. The Department of Natural and Cultural Resources, Division of Parks and Recreation (the Division) does not have a position on this legislation but would like to share the implications to the state park system.

This bill would provide free admission to day use state parks and recreation areas for the dependents of any active member of the armed forces as defined in RSA 21:50, II. Currently, our military discounts are as follows.

- NH disabled veterans are granted free admission to day-use areas, RSA 216-A:3-g, IV.
- Active members of the armed forces, including active and reserve members of the NH National Guard, are granted free admission to day-use areas, RSA 216-A:3-g, V, (a).
- Retired NH National Guardsmen in pay grade E6 or below are granted free admission to day-use areas, RSA 216-A:3-g, V, (b).
- Through our Fee Package, we also grant free parking at Hampton Beach South and Wallis Sands to all of the above categories of veterans and active military.
- In addition, during times of declared war, we provide free use of function spaces, such as pavilions, for active military and NH National Guard deployment and "welcome home" events, and a 50% discount on function space rentals for active military and NH National Guard family events (Fee Package). It has been difficult to determine if the military is currently operating under "times of declared war."
- In addition, we provide military discounts at Cannon Mountain. For example a NH resident military seasons pass is 35% of the cost of a full price season's pass (Fee Package).

When it comes to taking a position on granting free access to state parks, it is important to note that we wish that everyone could use our state parks for free. However, it takes substantial financial resources to take care of these wonderful places and make them accessible to the public. It is also very difficult for state park systems to compete for general fund dollars. This is why the Parks Fund was created in 1991. The House Appropriations Committee report that recommended passage wrote: *"This bill establishes the New Hampshire state park and ski areas as an enterprise-*

## type self-funded, accountable business entity to provide improved park and ski recreation facilities and services to New Hampshire citizens and tourists alike."

Attached is a summary of all of the existing free and discounted access totaling over one million dollars. To put this in context, the FY2020 Parks Operating budget, excluding ski area operations and the trails bureau, is \$12.5M, and the total FY2019 revenue from state park plates is \$854K. Of nearly one hundred parks, we collect fees at 40 park areas (day-use, camping and retail) and of those areas, only 25 generate a surplus to support the rest of the state park system and administration. The north region lost \$803,000 in 2018. The Division estimates that a loss of revenue to the State Park Fund from this legislation would be \$104.8K. Attached is an excerpt from our annual parks report showing a list of our income and expenses for each of the parks in 2018.

When determining whether or not to grant discounted or free access to our state parks, we ask you to please consider that in order for us to remain financially whole we will need to collect this revenue from somewhere else or reduce costs. This could mean increasing day use, parking and camping fees; cutting back on services, such as hours of operation or the length of the season that we are open; or reducing the amount of operating funds we have been investing to improve the condition of the state parks.

In FY 2012, we spent \$262,000 of operating revenue from the parks fund on improving the condition of our park system. From FY2014 through FY 2019, we averaged \$1.2 million of investment of operating funds per year. Projects supported with operating funds include the expansion of the Monadnock bathroom, new bathrooms at Jenness Beach and Umbagog, a new half million dollar radio system at Hampton Beach, the installation of playgrounds at Ellacoya beach and Lafayette campground, and hazard tree removal throughout the park system. This sort of investment was not always possible. In 2006, the parks fund had a 2.6 million dollar deficit.

We have not changed our Fee Package since 2012. While not all of our state parks are free, it is nonetheless important that the cost of access of is not a deterrent to anyone. The more visitors supporting the park system through their fees, the better the experience we can provide and the lower the fees are for everyone.

In conclusion, we urge you to please consider fully the impact on state park system and the consistency of this legislation with existing statutes and New Hampshire's self-funding model for the state park system.
